- 3. You must make arrangements for the Gloucester Harbour Trust to carry out an inspection of your boat(s). Please Note: The fee for the Harbour Trust Inspection is not included in the application fee and this must be paid separately to the Harbour Trust by the applicant.
- 4. Once the Harbour Trust has conducted the Inspection of the boat(s) a copy of the observations and recommendations will be submitted to the applicant and the Licensing Section. Please Note: The Licensing Section will not process the application until a report is submitted to the Licensing Section by the Harbour Trust.
- 5. Once the Licensing Section has received the Application Form, the appropriate Licensing Fee and the Harbour Trust Report, the matter will be deferred to the Licensing and Regulatory Committee for a decision and the applicant will be notified accordingly.

# THE FOLLOWING ARE THE TERMS AND CONDITIONS ON WHICH LICENCES ARE GRANTED AND WHICH WILL BE PRINTED ON THE LICENCE

- 1. That at the time of licensing, the Licensee undertakes that the hull of the boat or vessel is sound, that the boat or vessel is stable, that its equipment is complete and in good condition, and that it is generally sufficient for use as a pleasure boat or vessel.
- 2. That the Licensee undertakes that in all these respects the boat or vessel shall be maintained in an equal state of efficiency while it plies or is used for hire.
- 3. That the Licensee shall cause a statement of the fare or fares to be demanded and received from the persons using or carried for hire in such boat to be supplied to the appropriate Committee of the Council, and also to be clearly exhibited in some conspicuous position on or near the boat.
- 4. That the Council reserves to itself the right to suspend or revoke this Licence by notice in writing under the hand of the Head of Public Health & Culture.
- 5. That no boat or vessel must be used until
  - a) the official number shall have been painted on the outside of both sides of the bow and shall be not less than 4 inches in height and readable that a distance of 100 feet.
  - b) and the words "licensed to carry ...... passengers" (inserting the number of persons the vessel is authorised to carry by this licence) shall have been clearly painted inside the after end of the boat and shall be of a minimum height of 1<sup>1</sup>/<sub>2</sub> inches.

In each case the painting is to be executed and maintained to the satisfaction of the Harbour Master.

- 6. That the Licensee undertakes to comply with the following regulations:
  - i The boat when plying for hire shall carry on board at least two lifebuoys, which together with buoyant apparatus of a type approved by the Council's Inspector shall be of sufficient capacity for all the persons on board, two fire extinguishers (which shall be of a foam type conforming to appropriate British Standard specifications if the vessel is propelled by a petrol engine), boathook, painter, anchor and cable, heaving line, two balers, compass, six five star red distress flares and shall be fitted with a bilge pump.

Note - Lifebuoys may be substituted for the buoyant apparatus referred to in this paragraph and for this purpose one standard size Board of Trade lifebuoy shall be deemed to be sufficient to support two persons.

- ii No fuel tank or fuel cans shall be opened or manipulated while any passenger is on board.
- (iiia) Any petrol carried in excess of that contained in the fuel tanks shall be carried only in twogallon cans. Such cans, whether containing petrol or not, shall be stored in a closed locker which must not be used for any other purpose while any petrol can is therein. The locker must not be in close proximity to the exhaust pipe.
- (iiib) Up to 15 gallons of diesel fuel may be carried in substantial plastic containers with screw caps subject to the approval of the Council's Boat Inspector.
- iv A tray or receptacle, the sides of which are carried up as high as the propeller shaft will permit, shall be fitted beneath the engine and carburettor so as to prevent leakage of fuel and lubricating oil escaping into any other part of the boat. This Clause shall be in respect of petrol engine driven boats only.

- (v) Any flooring board shall be closely fitted, but made removable for inspection.
- vi The boat shall be kept clean and free from oil refuse
- vii The boat shall ply for hire in fine weather only and if operating before sunrise and after sunset must be equipped with navigation lights in accordance with the Merchant Shipping (Distress Signals and Prevention of Collisions) Regulation 1983 (b). The permitted area of operation is:-
  - (i) within
- viii A bell or an efficient whistle as defined in the regulations for preventing collisions at sea shall be carried on the boat for the purpose of denoting approach and to call for assistance if required, which shall not be used unnecessarily.
- ix The boat shall carry on board a copy of the regulations for preventing collision at sea, an accurate chart of the area in which the craft operates, a copy of the byelaws (where applicable) and a current tide table. If the boat exceeds 40ft in length it shall carry on board fog signalling apparatus.
- x The boat when plying for hire shall carry on board one licensed waterman qualified to manage, control and carry out running repairs to a licensed motor boat except self drive hire boats.
- XI The boat shall be provided with a reversible gear or reversing propeller, to enable it to be propelled astern.
- xii Each boat after taking its turn in disembarking its passengers shall, if there be any other boat or boats at or near to the landing stage awaiting a fresh load of passengers, sheer off from the landing stage and take its turn with the other boat or boats before embarking a fresh load of passengers from any public landing place.
- xiii Oil refuse or petroleum must not be deposited in the sea.
- xiv A speed boat shall be fitted with an efficient silencer and all practicable steps shall be taken to prevent noise in the running of the boat.
- xv All passengers carried in a speed boat shall be supplied with and wear a life jacket of a type approved by the Council Inspector.
- xvi The boat when plying for hire (unless a self drive hire motor pleasure boat) shall be fitted with or carry a serviceable VHF radiotelephone. Provided Always that if the licensee is having his radio telephone repaired of has notified the Harbour Office that his radio telephone is out of order then this requirement will be suspended for a period of 7 days from the date the radio telephone was left with the repairer or the date of notification to the harbour Office whichever date shall be the earlier in order that repairs to the radio telephone can be carried out.
- xvii The boat shall be capable of a minimum of 6 knots per hour for at least 30 minutes

The Council reserves to itself the right at any time to examine and inspect the said boat and its machinery.

7. The Licensee shall take out and maintain passenger insurance in the sum of £2M and the policy and current premium receipt for such insurance shall be produced on request and the

policy shall be endorsed to the effect that the Council shall be notified prior to any change in the cover, or on the expiry or other termination thereof.

# NOTE:

- 1. The Council does not assume the responsibility of testing the accuracy of the representations upon which this Licence is granted, nor do they warrant by this Licence the safety of any boat or the competency of any boatman. This Licence is no way tends to remove from the Licensee the responsibilities which would otherwise fall upon him for wrongful acts or defaults, or for the employment of incompetent persons, or for the use of an unsafe or insufficiently equipped boat or vessel.
- 2. The attention of the applicant is directed to:-
  - I Any Byelaws relating to pleasure boats and vessels made from time to time by the Council.
  - ii Section 94 of the Public Health Acts Amendment Act 1907.
- 3. Regarding condition 5, the Harbour Master requires the numbers painted on the outside of the bow on both sides to be of a size not less than 4 inches in height and readable at a distance of 100 feet, and the lettering inside the after end of the boat to be a minimum height of 1<sup>1</sup>/<sub>2</sub> inches. Observations and recommendations from the Harbour Master will be taken into account.
