

PAYMENT OF COUNCIL TAX

Council Tax is payable in instalments. For existing accounts the full year charge is spread over 10 instalments each one due by the 15th of each month April to January in each financial year. You may now request to have instalments spread over the full year. Please call us on 01633 644630. (Direct debits payers have a choice of payment dates - see below). For demands issued after 1st April, the number of instalments available will be reduced as necessary. Payment may be made in two ½ yearly instalments **by prior agreement for each financial year**. Payment due dates 15th April and 15th October.

If you prefer to pay your account in full, your payment should reach us by your first instalment due date. Please note - **discount is no longer given for early settlement.**

By Direct debit

The easiest way to pay – you will also have a choice of four payment dates, the 1st, 8th, 15th and the 24th of each month - choose the date most convenient for you. Please call us on **01633 644630**, we will be happy to arrange this for you. You can also complete a direct debit instruction from our website - address below.

By Telephone

Our **Automated Telephone Payment facility** is available **24 hours a day, 7 days a week** and takes payment by debit or credit card. Ensure you have your council tax account and card details available. **Tel. 0845 3723601**. This call will cost you 3 pence per minute plus your phone company's access charge.

Pay On-Line

We operate a secure payment facility at www.monmouthshire.gov.uk Look for the "Pay for a Service" button. Ensure you have your 9 digit council tax account number and card details available. You can use your debit or credit card. Payments made by 6.00pm will be credited to your account the following day.

Please note – Payments by cash cannot be accepted.

A courier service is available for cheques deposited at the Council Hubs. These should be placed in an envelope with sufficient information for the payment to be correctly allocated. Please put your name, address and council tax account number on the reverse of the cheque.

N.B NO RECEIPTS WILL BE GIVEN FOR CHEQUE PAYMENTS RECEIVED BY POST OR COURIER SERVICE UNLESS SPECIFICALLY REQUESTED **AND ACCOMPANIED BY A STAMPED ADDRESSED ENVELOPE.**

By internet banking or standing order

You will have to arrange this with your bank and ensure that payments are made as required. Please quote **sort code 20 18 15 and bank account 43972321** in addition to your own council tax account number.

Payments may take up to 7 days to reach your account.

LATE PAYMENTS

Payments should be received on or before the due dates. Your right to instalments could be lost if Reminder Notices are issued for overdue payments. If it is necessary to issue a Summons Notice, the full balance will be payable and costs will be incurred.

Payable on issue of a Summons - £40. Payable on issue of a Liability Order - £30

If the summons is not paid in full (including £40 costs) by the Court hearing date, the Council will proceed with the case and request a Liability Order adding further costs of £30. A Liability Order enables the Council to take further action to recover the debt.

ENTITLEMENT TO COUNCIL TAX REDUCTION, DISCOUNTS OR EXEMPTIONS

If you are entitled to Council Tax Reduction, a detailed explanation of the reasons for that reduction are set out on the separate notification letter. If the amount shown as payable on this demand is reduced by Council Tax Reduction, discount or exemption, you are required to advise the Council of any change of circumstances that might affect that entitlement.
