This Order is made by Monmouthshire County Council ("the Council") under Section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to divert the footpath to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely to allow for the building of a new dwelling as approved in planning application DC/2014/00112.

BY THIS ORDER:

- 1 The footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be diverted as provided below.
- 2 There shall be created to the reasonable satisfaction of the Council an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
- The diversion of the footpath shall have effect on the confirmation of this 3 Order.
- The Landowner as applicant for this Order is hereby required to pay for the 4 cost of carrying out the said works.
- 5 Where immediately before the date on which the footpath is diverted there is apparatus under, in, over, along or across it belonging to statutory undertakers for the purposes of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.



Public Footpath No.8 (Part) Llanarth Fawr - commencing at Point A (SO3869808950) at a width of 2m to a pedestrian gate at Point D (SO3865008881). From Point D the footpath continues at a width of 2m a distance of 3m along the field entrance track to the edge of the main vehicular access track at Point G (SO3864208879). From Point G the footpath continues on a level ground to the side of the vehicular access track in a South Easterly direction 74m to a pedestrian gate at Point E (SO3869908831). From Point E the footpath continues at a width of 2m in a Southerly direction 19m along the track to the R64 Charthouse- Raglan Road at Point F (SO3870308812) as shown on the map attached to the order.
