To divert:-

Public Footpath No.24 Magor with Undy (formally 24 Undy) – commencing at Point E (ST4378287662) on The Elms County Road and continues in an East South Easterly direction a distance of 149m to point B (ST4392287613). From Point B the Footpath continues in an East South Easterly direction a distance of 25m to point F (ST4394587605) at the community boundary.

Public Footpath 23 Rogiet (formally 4 Llanfihangel Rogiet) - commencing at the community boundary at point F (ST4394587605) and continues in a South Easterly direction a distance of 146m to the B425 County Road at point G (ST4402787484).

To a line running from:-

Public Footpath No.24 Magor with Undy (Undy) - commencing at Point A (ST4378687678) on The Elms County Road and continues at a width of 2m in an East South Easterly direction along a walkway a distance of 151m to point B (ST4392287613). From Point B the footpath continues along the walkway at a width of 2m in an East South Easterly direction a distance of 18m to point C (ST4399887587). From Point C the footpath continues along the walkway at a width of 2m in a South South Easterly direction to the B425 County Road at point D (ST4399887487) as shown on the order map.
