Caldicot Town Centre Targeted Regeneration Investment Scheme Urban Centre Property Enhancement Fund/Urban Centre Living Grant Expression of Interest Form

The 'Caldicot Town Centre Targeted Regeneration Investment Scheme' provides financial support for eligible improvements to properties in designated areas of Caldicot Town Centre (see attached eligibility map)

The objective of the scheme is to achieve an enhanced and integrated approach to the physical regeneration of Caldicot, reactivating vacant or underutilised commercial and living space, safeguarding existing businesses and encouraging additional private sector investment.

Financial support for up to 70% of eligible works can be considered - to a maximum of £250k

The scheme is open to freehold owners of property within the eligible boundary or leaseholders with a minimum outstanding lease of 7 years.

Typically, works to the publicly viewable exterior and curtilage of a building, which make a significant contribution to the enhancement of the targeted area can be considered. However, in certain circumstances, internal reconfiguration work that facilitates improved commercial activity or 'in town' living, can also be considered.

The Council will prioritise projects that meet the aspirations of the Town Centre Regeneration programme (please see the Design Guide at https://www.monmouthshire.gov.uk/caldicot-regen and commitments made to funding partners on the creation of improved commercial space and town centre living, safeguarding/creation of jobs and other outcomes.
