



Crick Landscape Sensitivity of Candidate Sites

Settlement Crick

SUMMARY

Key characteristics

Very gentle lower slopes beneath rising hill in Caerwent defence base to the north.

A brownfield site with hardstandings and semi-derelict buildings.relating to former depot with regenerating scrub on edges and trimmed hedge and trees to the southern A48 road frontage.

Former railway wooded embankment forms a strong buffer and screen to the west.

The area's tranquillity is affected by it proximity to the A48 and infrastructure of the site and military base.

Landscape sensitivity medium/low

The susceptibility of the site lies in its trees and hedges on its frontage, its role separating Crick and Caerwent and visibility from the A48. The LANDMAP value is high for visual and sensory, cultural landscape and geological landscape. The presence of the railway embankment to the east is helpful as being a clear physical boundary to the extent of the built settlement in Crick. This site has a lower sensitiivty than its LLCA because it is a brownfield site at a lower level closely associated with the settlement. As such it has potential for housing development as the westernmost extent of Crick, retaining the screening embankment to the west and with a carefully designed frontage as the gateway to the settlement.

SUMMARY

Key characteristics

Very gentle lower slopes beneath rising hill within Caerwent defence base to the north.

Triangular arable field with trees to the north west and close to the road to the south with very gappy hedge to the north east.

Settlement to south.

Views from the rural road to the south east.

The area's tranquillity is affected by it proximity to the settlement and infrastructure of the site and military base.

Landscape sensitivity medium/low

The susceptibility of the site lies in its trees and hedges and its exposure to views from the rural road to the south east. The LANDMAP value is high for visual and sensory, cultural landscape and geological landscape. This site has a lower sensitivity than its LLCA because it is at a lower level closely associated with the settlement and partly screened from the north east. As such it has potential for housing development as the north easternmost extent of Crick, retaining the tree and native shrub boundary to the north east, which should be strengthened and retaining the majority of the woodland belt to the west.
