# UNIT 67 ABERGAVENNY MARKET HALL, MONMOUTHSHIRE, NP7 5HD

## LOCATION

Abergavenny Market Hall is located on Cross Street in the heart of the town of Abergavenny (see map below). The stall is located on the ground floor to the rear of the hall, attracting high levels of passing footfall/trade.

## DESCRIPTION

The shop has a Net Internal Area (NIA) of 13.9sqm (150 sq ft) approx. The unit is self-contained, constructed of timber and block, has an access door and a quarry tiled floor.

## TRADING TERMS

Available to trade 7am to 5pm every Tuesday, Wednesday, Friday and Saturday throughout the year, except for Christmas Day and Boxing Day. Any other dates that may become available will be communicated and notice provided.

It is expected that the winning bidder will keep open and trade from the stall on the main market days.

## TENURE AND PROPOSED LICENCE TERMS

Whilst terms can be flexible, it is proposed that the shop will be available on a licence agreement for an initial period of 6 or 12 months that will then revert to a monthly arrangement. Trader to be responsible for dressing the unit; decorating, signage and fitting out details to be agreed with the Council.

Monthly licence fee will initially be on an inclusive basis (to include water, electric and business rates). However, the Council reserve the right to recharge or collect a service charge in relation to these costs. It is proposed that the Licence fee will be reviewed on an annual basis.

## SERVICES

The shop benefits from water and electricity supply. The water supply is currently switched off but can be reinstated if required.

## MAKING A BID

The unit is available by way of an informal tender, with **best bids lodged at Markets Office by 12:00 noon on Friday 29<sup>th</sup> April 2022.**

All bids must be sealed, clearly marked **"Market Hall Unit 67 Letting Tender"** and within an easily identifiable envelope.
