### CONSOLIDATION ORDER 2019 (AMENDMENT NO.1) (PART 2) 2020

MONMOUTHSHIRE COUNTY COUNCIL in exercise of their powers under the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 of the Act hereby make the following Order:-

- 1. The Monmouthshire County Council (Traffic and Speed Limit) Consolidation Order 2019 is hereby amended as specified below. The effect of the Order will amend the restrictions on the following roads and amend the Monmouthshire County Council (Traffic and Speed Limit) Consolidation Order 2019 ("the Consolidation Order") in that the maps titled (Existing) shall be amended and the maps titled (New) in the Schedule to this Order shall be implemented.
- 2. The Order may be cited as the "Monmouthshire County Council (Traffic and Speed Limit) Consolidation Order 2019 (Amendment No. 1) (PART 2) and shall come into operation on 9 April 2020.
