is allowing water into the		
property and some of the		
brickwork is coming		
loose. We propose		
replacing the mortar		
using similar material. If		
individual bricks are in		
too poor a condition to		
reuse, we will source		
new or reclaimed bricks		
as close to the original		
as possible, and will be		
replaced without altering		
the outward appearance		
or dimensions of the		
chimneys. The chimneys		
will then be rendered to		
restore the finish as it		
was prior to degradation.		
Scaffolding will be		
required during the		
works. Building supplies		
will be brought on site on		
the existing access route
