### **MONMOUTHSHIRE COUNTY COUNCIL TRAFFIC REGULATION, SPEED LIMITS AND PARKING REGULATIONS CONSOLIDATION ORDER 2019 (AMENDMENT ORDER NO 6) 2022**

#### **PROVISION AND AMENDMENTS TO TRAFFIC ORDERS WITHIN VARIOUS COMMUNITIES IN MONMOUTHSHIRE**

Monmouthshire County Council (the 'Council') in exercise of their powers under the Road Traffic Regulation Act 1984 (the '1984 Act') and the Traffic Management Act 2004 (the '2004' Act) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

#### **1 CITATION AND COMMENCEMENT**

This Order shall come into operation on .....and may be cited as Monmouthshire County Council Traffic Regulation, Speed Limits and Parking Regulations Consolidation Order 2019 (Amendment Order No..6) 2022

#### **2 THE ORDER**

Monmouthshire County Council Traffic Regulation, Speed Limits and Parking Regulations Consolidation Order 2019 is amended by:

##### **CAR PARKING**

(a) The following amendments of Schedule 2:

(i) the addition after No 43 on Page 52 of

- (ii) amend the description at Number 37 on Page 50 from “Wyebridge Car Park, Monmouth” to Wyebridge Street Car Park, Monmouth and amend the charges to :
- £1.50 for the first 2 hours or part thereof
  - £1.90 for 3 hours or part thereof
  - £2.40 for 4 hours or part thereof
  - £4.80 for all day
  - £18.00 for 5 days
  - £21.50 for 6 days
  - Long Stay Car Park season permit at £430 per annum, £220 half year, £110 quarterly
- (iii) at No. 3 on Page 38 amend Column (2) by the addition after “Caravans” of “and Motorhomes”
- (iv) the removal of “Overstay Penalty Payment, first hour only - £5.50” wherever it appears in Column (5)

(b) In Article 1.9 insert the following definition in the appropriate place:

“Electric Vehicle Bay” means a space within a Parking Place set aside for the charging of electrically propelled vehicles and indicated by the appropriate markings

(c) An additional article 7.1.20 shall be added as follows:

“No person shall cause or permit any vehicle other than an electrically propelled vehicle to enter or remain in an Electric Vehicle Bay except when that vehicle is being charged and no vehicle shall in any event remain in an Electric Vehicle Bay for more than 4 hours.”

### 3 Road Traffic

- (a) The introduction of a prohibition of driving on Frogmore Street and part of Lion Street, Abergavenny as shown on the attached plan 1953. Driving is hereby prohibited Monday to Sunday between 10am and 4pm and prohibited Monday to Sunday between 4pm and 10am, excepting for loading.
- (b) The introduction of a motorcycle only parking area at Abergavenny Bus Station as shown in the attached plan 1952
