- (a) cyflwyno terfyn cyflymder o 30mya ar y B4293 yn y Gymuned y Dyfawden fel y dangosir ar y cynllun atodedig Rhif 1943,
- (b) cyflwyno terfyn cyflymder o 20mya a therfyn cyflymder o 30mya ar y B4245 ac o derfyn cyflymder o 30mya ar Caldicot Road yng Nghymuned Cil-y-coed fel y dangosir ar y cynlluniau atodedig wedi'u rhifo 1944-A a 1944-B a

**MONMOUTHSHIRE COUNTY COUNCIL
Traffic Regulation, Speed Limits and Parking Regulations Consolidation Order 2019 (Amendment Order No. 5) 2022**

Provision and Amendments to Traffic Orders at Caldicot and Devauden

Monmouthshire County Council (the 'Council') in exercise of their powers under the Road Traffic Regulation Act 1984 (the '1984 Act') and the Traffic Management Act 2004 (the '2004' Act) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

1 CITATION AND COMMENCEMENT

This Order shall come into operation on *31st January 2023* and may be cited as Monmouthshire County Council Traffic Regulation, Speed Limits and Parking Regulations Consolidation Order 2019 (Amendment Order No.5) 2022

2 THE ORDER

The Monmouthshire County Council Traffic Regulation, Speed Limits and Parking Regulations Consolidation Order 2019 is amended by:

- (d) the introduction of a 30mph speed limit on the B4293 in the Devauden Community as shown on the attached plan Number 1943,
- (e) the introduction of a 20mph speed limit and a 30mph speed limit on the B4245 and of a 30mph speed limit on Caldicot Road in the Caldicot Community as shown on the attached plans numbered 1944-A and 1944-B and
- (f) the revocation of the plan tiles and their replacement with the revised plan tiles as listed and referenced in the table below.
