## NOTES

- 1. Revised charges to be applied for all burials from 1 April 2022
- 2. <u>Out of County Charges</u> will apply where the deceased was living outside of Monmouthshire at the time of their death. Exceptions to the rule are as follows:
  - 2.1 If a burial plot has been reserved/purchased by a Monmouthshire resident who subsequently leaves the County, and is then residing outside of Monmouthshire at the time of their death.
  - 2.2 Members of the Armed Forces (the serving individual and their spouse married or co-habiting partner) with family links in the area.
  - 2.3 Monmouthshire residents that have needed to move out of the county to receive specialist care e.g. a nursing home or to move in with a family member for care support up to a period of 10 years from the date of moving out of the county. NB Those who move out of Monmouthshire to downsize or to move closer to relatives will not be eligible for this exemption.
  - 2.4 Re-opened graves, where an interment has already taken place, will not be subject to Out of County charges.
  - 2.5 All children's burials
- 3. No new contract for upkeep of graves should be entered into
- 4. The levy or collection of Ministers' fees to be a private arrangement
- 5. Charges include all necessary documentation
- 6. All fees are to be paid at the time of booking
- 7. All charges are exempt from VAT
- 8. Refer to full guidance notes for information regarding the ERB processes in place regarding re-erection of safety test failed memorials and other remedial works
- 9. Burial times at Monmouthshire cemeteries:

## The latest burial times at Council cemeteries are as follows:

From November to February 2.00 pm Monday to Friday From March to October 3.00 pm Monday to Thursday and 2.00 pm on Friday

If a full burial is required after these times and it is safe to permit it, an additional fee of £220 will be charged Monday to Friday and £440 on a Saturday. For cremated remains interments £110 and £220 respectively.

- 10. If a test dig to check if there is sufficient depth for another interment is required an additional charge of £83 will be incurred, however if there is sufficient room then the charge will be waived.
- 11. Saturday burials are possible, but are strictly upon application with no guarantee that staff will be available and will incur additional costs of £440 in addition to the above charges for full burials and £220 for cremated remains.
- 12. The cost for an exhumation of a full coffin will be a minimum of £550 payable at the time of application and any remaining balance to be determined following the conclusion of the proceedings. The exhumation of cremated remains will be charged at a fixed price of £275
- 13. Coffins more than 30" wide will require 2 grave spaces and will incur the additional charge for the second space as per the charges above.
