ROAD TRAFFIC REGULATION ACT 1984

**CROSS STREET AND MARKET STREET, ABERGAVENNY, MONMOUTHSHIRE
TRAFFIC REGULATION ORDER 2023**

Monmouthshire County Council (the 'Council') in exercise of their powers under the Road Traffic Regulation Act 1984 (the '1984 Act') and the Traffic Management Act 2004 (the '2004' Act) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

CITATION

1. This Order shall come into operation on 15th September 2023 and may be cited as the Cross Street and Market Street, Abergavenny, Monmouthshire Traffic Regulation Order 2023
2. The Monmouthshire County Council Cross Street, Market Street, Abergavenny (Experimental) Traffic Regulation Order 2022 shall be revoked on the coming into operation of this order.

THE ORDER

3. CROSS STREET AND MARKET STREET, ABERGAVENNY

To implement a Prohibition of Driving (except for access) Order on (a) Cross Street from its junction with Lower Castle Street to its junction with Market Street and on Market Street from its junction with Cross Street to its junction with the exit from Brewery Yard car park identified on the plan attached to the Order Schedule. This Prohibition of Driving (except for access) Order shall be operative from 10 am to 4 pm, Monday to Saturday.

4. This Order shall have the effect of amending the Monmouthshire County Council (Various Roads) (Traffic Regulation and Speed Limit) Consolidation Order 2019, in that the Map Schedules specified in the First Schedule shall be amended and the Map Schedule specified in the Second Schedule to this Order shall be implemented.
5. Nothing in Article 3 shall apply to any motor vehicle being used by or on behalf of :
 - a. An individual, party or organisation authorised by the Council;
 - b. The police, fire brigade or ambulance service.

6. No restrictions imposed by this Order shall apply to vehicles falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when being used in accordance with Regulation 3(5) of those Regulations.

2. Bydd Gorchymyn Rheoleiddio Traffig (Arbrofol) 2022 Cyngor Sir Fynwy, Stryd y Groes a Stryd y Farchnad, Y Fenni yn cael ei ddirymu pan ddaw'r Gorchymyn hwn i rym.

3. STRYD Y GROES A STRYD Y FARCHNAD, Y FENNI

Gweithredu Gorchymyn Gwahardd Gyrru (ac eithrio mynediad) ar (a) Stryd y Groes o'i chyffordd â Rhan Isaf Stryd y Castell i'w chyffordd â Stryd y Farchnad ac ar Stryd y Farchnad o'i chyffordd â Stryd y Groes i'w chyffordd â'r allanfa o lard y Bragdy maes parcio a nodir ar y cynllun sydd ynghlwm wrth Atodlen y Gorchymyn. Bydd y Gorchymyn Gwahardd Gyrru (ac eithrio mynediad) hwn yn weithredol o 10 am i 4 pm, o ddydd Llun i ddydd Sadwrn.

4. Effaith y Gorchymyn hwn fydd diwygio Gorchymyn Cydgrynhoi Cyngor Sir Fynwy (Ffyrdd Amrywiol) (Rheoleiddio Traffig a Therfyn Cyflymder) 2019, sef y bydd yr Atodlenni Mapiau a bennir yn yr Atodlen Gyntaf yn cael eu diwygio a'r Rhestr Fapiau a bennir yn yr Ail Atodlen i'r Gorchymyn hwn yn cael ei gweithredu.

5. Ni fydd dim yn Erthygl 3 yn gymwys i unrhyw gerbyd modur a ddefnyddir gan neu ar ran :

- a. Unigolyn, parti neu sefydliad a awdurdodwyd gan y Cyngor;
- b. Yr heddlu, y frigâd dân neu'r gwasanaeth ambiwlans.

6. Ni fydd unrhyw gyfyngiadau a osodir gan y Gorchymyn hwn yn gymwys i gerbydau sy'n dod o dan Reoliad 3(4) o Reoliadau Eithriadau Traffig Ffyrdd (Grymoedd Arbennig) (Amrywio a Diwygio) 2011 pan gânt eu defnyddio yn unol â Rheoliad 3(5) o'r Rheoliadau hynny.
