Order No. 14) 2024**

Provision and Amendments of Traffic Orders at various locations in Caldicot, Monmouth, Portskewett, Llantilio Pertholey and Gilwern

Monmouthshire County Council (the 'Council') in exercise of their powers under the Road Traffic Regulation Act 1984 (the '1984 Act') and the Traffic Management Act 2004 (the '2004' Act) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

1 CITATION AND COMMENCEMENT

This Order shall come into operation in a staggered manner on dates given in each provision below. The order may be cited as Monmouthshire County Council Traffic Regulation, Speed Limits and Parking Regulations Consolidation Order 2019 (Amendment Order No.14) 2024

2 THE ORDER

Monmouthshire County Council Traffic Regulation, Speed Limits and Parking Regulations Consolidation Order 2019 is amended by:

- a) the introduction of the restrictions and amendments set out in the plans and descriptions listed below:
