1. Provision of Public Open Space

- 1.1. The Council is committed to providing open spaces within Monmouthshire that are important for recreation, amenity, biodiversity, connectivity and/or heritage. Access to areas of public open space is essential in enhancing the quality of life for all and providing sustainable and resilient communities. It can help foster social inclusion, assist in healthier lifestyles and allow for recreation and leisure activities. It is important therefore that there is a provision of an accessible network of open spaces for Monmouthshire's communities.
- 1.2. The purpose of this study is to set out the findings of the Open Space Study which has been prepared as part of the evidence base for the Replacement Local Development Plan (RLDP) which covers the period 2018-2033. The study assesses the quantity of existing public open space provision within the county and assess this provision with the benchmark standards endorsed by Fields In Trust (FIT)¹.
- 1.3. This benchmark standard of open space provision informs Policy CI2 of the RLDP 'Provision of formal and informal open space and allotment/community growing areas', which sets out that new development proposals will be assessed against this standard. The findings of this study, therefore, can be used as a means of justifying the provision of new open space facilities and/or remedying local deficiencies in provision. It can also be used as a means of safeguarding and enhancing existing facilities, as set out in Policy CI3 of the RLDP 'Safeguarding existing recreational facilities, public open spaces and allotments/community gardens.'
- 1.4. The findings of this study can also assist in seeking S106 obligations from developers where new housing development increases local need and will provide supportive evidence to the Council's adopted planning framework².
- 1.5. It should be noted that this study only represents a quantitative analysis of open space provision, and other considerations related to accessibility and the quality of existing provision have not been assessed. In this regard, an 'Area of Amenity Importance (AAI) Review' has been undertaken which has assessed Monmouthshire's open spaces for their quality and protection.

2. Standards and Definitions

2.1. For the purpose of this study, Monmouthshire's public open space has been categorised as per the FIT standard into; formal outdoor spaces, which includes sports pitches and equipped play areas; and informal outdoor spaces, which includes parks, amenity green spaces and natural and semi- natural spaces. The Council has adopted this as their standard for open space provision, set out in Policy CI2 of the RLDP.

3. Geographical Extent of the Study

- 3.1. To ensure a comprehensive audit of the county was surveyed, the study was broken down into settlement areas in accordance with the Sustainable Settlements Appraisal (SSA), with the following settlements surveyed.³
 - **Primary Settlements** Abergavenny inc. Llanfoist, Chepstow, Monmouth inc. Wyesham, Caldicot inc. Severnside settlements of Caerwent, Crick, Magor Undy, Portskewett, Sudbrook, Rogiet.
 - Rural Secondary Settlements Usk, Raglan, Penperlleni.
 - Main Rural Settlements Devauden, Dingestow, Little Mill (inc. Monkswood), Llandogo, Llanellen, Llangybi, Llanover, Llanvair Discoed, Mathern, Pwllmeyric, Shirenewton/Mynyddbach, St Arvans, Tintern, Trellech, Werngifford/Pandy.
 - Minor Rural Settlements Broadstone, Catbrook, Cross Ash, Grosmont, Llanarth, Llanddewi Rhydderch, Llanishen, Llansoy, Llanvapley, Mitchel Troy, Penallt, Penpergwm/ The Bryn, The Narth.
- 3.2. The study does not cover spaces in open countryside locations generally outside of settlement boundaries. If however, there were some open spaces identified outside settlement boundaries that are connected and accessible to nearby communities, then these have been included within the audit.

4. Methodology

- 4.1. The methodology undertaken to review the county's open space provision involved:
 - **Desk Top Assessment** review of relevant LDP evidence base studies, such as the previous 2008 Open Space Study, and identifying open space areas on Council mapping systems.
 - **Site Survey and Appraisal** site surveys were undertaken to verify the desktop assessments and provide information on the typology of open spaces identified.
 - GIS Mapping open space areas were mapped using GIS software which provided the size of sites in hectares (ha) and provided the quantitative total amount of open space provision in the settlements listed above. In association with the maps, tables were produced giving each area of open space a typology and unique reference (OPS001, OPS002 and so on).
 - Application of the FIT Standard areas of the open space mapped were compared to the FIT standard of provision per 1,000 population. This resulted in either a deficit or surplus provision of each open space typology for each settlement.
- 4.2. This a 'living' study with a base date of October 2024. The study has been based on site information and surveys at a point of time. Moreover, it is recognised that some categories could fall into multiple typologies of open space criteria, particularly within the informal open space criteria. For example, amenity green spaces can

overlap with parks and gardens and natural and semi natural spaces. To avoid any double counting, an area of open space identified has only been given one typology.

5. Summary Analysis of Open Space Provision

- 5.1. Overall and as set out in Table 2 below, Monmouthshire's Primary Settlements and most sustainable settlements of Abergavenny inc. Llanfoist, Chepstow, Monmouth inc. Wyesham and Caldicot have the largest amount of open space provision, both in terms of formal and informal open space.
- 5.2. In relation to formal outdoor space provision, both Abergavenny/Llanfoist and Chepstow have a deficit in all areas against the FIT standard. Monmouth and Caldicot also have a deficit of outdoor sport and designated play areas, although they both have a surplus of other outdoor provision due to a good level of MUGA provision at Monmouth Comprehensive School/Leisure Centre and Caldicot Comprehensive School/Leisure Centre respectively. Monmouth is the only Primary settlement to have surplus of playing pitch provision due to good sized provision at Chippenham fields.
- 5.3. In relation to the Secondary Settlements, Usk, Raglan and Penperlleni all have deficits in formal outdoor space provision. Usk and Raglan, however, do have a surplus of playing pitches provision due to good sized provision at Usk Athletic Club and at Station Road Raglan.
- 5.4. In relation to Monmouthshire's rural settlements there are mostly deficits in formal outdoor space, particularly in outdoor sport and other outdoor sport provision. Some of the settlements, however, namely Llanarth, Llanvapley, Little Mill inc. Monkswood and Penallt have surplus provision of playing pitches, due to their good-sized cricket pitches.
- 5.5. In terms of informal open space, the County has good provision in terms of total amount with nearly all settlements having provision and the majority of settlements having a surplus of provision of amenity green space. Due to the nature of Monmouthshire's settlements being predominately rural, the County has a limited amount of designated park provision as these are more typical of urban towns and cities. Two Parks have been identified within the settlement of Abergavenny/Llanfoist. A few smaller parks/gardens have been identified within Monmouth/Wyesham and Chepstow.
- 5.6. Few natural and semi natural land has been identified and this is considered to be largely due to restricted access to these types of spaces, although it is acknowledged that PROW networks will give access through private areas of natural and semi natural land. Natural and semi natural spaces, such as woodlands and grassland are also considered more akin to areas that surround settlements. As this study audits the open spaces within defined settlements, it does not include accessible areas of 'open countryside' land which surrounds most of Monmouthshire's settlements. In this respect, Monmouthshire's Countryside Access Improvement Plan (CAIP) 2020-2030 sets out information on plans and delivery actions to increase access to Monmouthshire's open countryside spaces and PROW network.

Outdoor Sport Provision

- 5.7. In terms of outdoor sport, none of the surveyed settlements (with the exception of rural settlement Llanarth) have been identified as having a surplus of provision against the FIT standard. The Primary Settlements of Abergavenny inc. Llanfoist, Chepstow, Monmouth inc. Wyesham and Caldicot, however, all have some provision and although Abergavenny has the most provision in terms of absolute amount (6.44ha), proportionally in relation to standard (see Table 4) it had the greatest deficit of-18.26ha. There is some provision of outdoor sport in Caldicot (2.97ha), however, the rest of the Severnside settlements: Magor with Undy, Rogiet, Portskewett, Sudbrook, Caerwent and Crick do not have any outdoor sport provision. In this respect, it is considered Caldicot, functioning as the Primary Settlement of the Severnside region serves the Severnside region for outdoor sport provision.
- 5.8. All Secondary Settlements have a deficit of outdoor sport provision, although both Usk and Raglan have some outdoor sport provision, with tennis courts and cricket nets at Usk, and tennis and basketball courts at Raglan. Penperlleni, however, does not have any outdoor sport provision.
- 5.9. Similarly, most of Monmouthshire's rural settlements have a deficit of outdoor sport provision, with the exception of Llanarth that enjoys a well-established and good-sized recreation ground with cricket nets (as well as cricket pitch). There is also some outdoor provision at Dingestow, Little Mill, Llangybi, Shirenewton, Tintern, Werngifford Pandy, Llanvapley, Llandewi Rhydderch and Penallt.

Playing Pitch Provision

- 5.10. In terms of sports pitch provision, all of the Primary Settlements have some provision, however, Abergavenny with Llanfoist, Chepstow and Caldicot all have a deficit of provision. Only Monmouth including Wyesham has a healthy provision of 18.23ha and against the FIT standard a surplus of 5.42ha (see Table 6). The Severnside settlements of Magor/Undy, Rogiet, Portskewett, Sudbrook, Caerwent all have some provision of playing pitches, however, they all do have a deficit in provision against the FIT standard.
- 5.11. In relation to our Secondary Settlements, both Usk and Raglan enjoy a surplus provision with good provision at Usk Athletic Club, as well as Usk Rugby Club and Station Road, Raglan. In contrast, Penperlleni has a deficit in provision, although there is provision of sport pitches at Penperlleni's recreation ground and Goytre Football Club.
- 5.12. In relation to Monmouthshire's rural settlements, a number of the settlements do enjoy a surplus provision of sports pitches. This includes Little Mill, inc. Monkswood, where there is a good-sized cricket pitch at Monkswood, Mathen, St Arvans, Catbrook, Cross Ash, Llanarth, Llanvapley and Penallt. There is also provision but deficit against the FIT standard at: Devauden, Dingestow, Llanellen, Llanvair Discoed, Tintern and Werngifford Pandy.

Designated Play Area Provision

- 5.13. In terms of designated play provision, all of the County's Primary Settlements, Severnside Settlements and Secondary Settlements having a deficit of provision. It is recognised, however, that this is a quantitative study in relation to the FIT standards and as referred to in footnote 2 the Council's approach is to move away from quantitative provision (i.e. lots of smaller play areas with limited play value) in favour of play experience and quality of play, thus endorsing funds towards quality improvement of existing destination areas of play.
- 5.14. In relation to designated play provision in our rural settlements, most rural settlements have some play provision with only a few of the settlements surveyed having no provision at all (Llansoy, Grosmont and Cross Ash). Some of the rural settlements also enjoy a surplus of provision which include: Devauden, Dingestow, Little Mill, Llandogo, Werngifford Pandy, Llanarth, Llanvapley, Llandewi Rhydderch and Mitchel Troy. As stated, however, the survey did not assess the quality and play value of these play areas.

Other Outdoor Provision

- 5.15. With regards to other outdoor provision, there is provision in all of our Primary Settlements, with all having MUGA provision at their leisure centre facilities (King Henry VIII School in Abergavenny) and all four settlements having provision of a skate park. Monmouth/Wyesham and Caldicot both enjoy a surplus of outdoor provision while Abergavenny/Llanfoist have a deficit of-3.62 ha (see Table 4) and Chepstow a deficit of-1.11ha (see Table 5).
- 5.16. There are also MUGAs within Magor/Undy and Rogiet, however, the provision is recorded as a deficit. Portskewett, Sudbrook, Caerwent and Crick have no other outdoor sport provision.
- 5.17. In relation to our Secondary Settlements, both Raglan and Penperlleni have no provision and therefore record a deficit. Usk however does have a MUGA at the Athletic Club grounds, however it is also in deficit of-0.68ha (see Table 12).
- 5.18. There is very limited other outdoor provision in our rural settlements, with only Little Mill and Mathern enjoying MUGA facilities.

Amenity Green Space

- 5.19. In terms of amenity green space, Monmouthshire's settlements have good provision, with nearly all settlements having some provision. In relation to our Primary Settlements, Caldicot is identified has having the greatest total amount of amenity green space with 39.73ha and a surplus of 33.53ha (see Table 7). This is largely attributed to the open grounds at Caldicot Castle, as well as the newly created open space at the Church Road housing development. Abergavenny including Llanfoist also enjoys a large total amount of amenity green space with a surplus of 29.35ha, which is mainly attributed to Castle Meadows amenity area. Monmouth including Wyesham has a surplus of 23.99ha and Chepstow a surplus of 17.12ha. Overall, there is a healthy provision of amenity green space within our Primary settlements.
- 5.20. There is also surplus provision of amenity green space in the majority of our Severnside settlements. Magor with Undy enjoys a surplus of 4.04ha with a large new area of amenity green space recently created as part of the Rockfield Road new

- housing development. Rogiet has a surplus of 5.43ha, Portskewett and Sudbrook 6.12ha, and Caerwent 1.39ha. However, the smaller cluster settlement of Crick does not have any provision.
- 5.21. With regards to our Secondary Settlements, although all three settlements do have provision, only Usk has surplus provision, with both Raglan and Penperlleni falling short of the standard.
- 5.22. The majority of our rural settlements also have surplus amenity green space provision, with just a few having deficit or no provision (Little Mill, Llanvair Discoed, Mitchel Troy and The Narth).

Parks and Gardens

5.23. In relation to Parks and Gardens, these have only been identified within the Primary Settlements of Abergavenny/Llanfoist at Bailey Park and Linda Vista Gardens; Monmouth/Wyesham, a small park area identified just outside Vauxhall Fields; and smaller parks within Chepstow, two of which have recently been formed as part of the new Fairfield Mabey residential development. Overall, there is no surplus of parks and garden provision with the County, with all the settlements having a deficit.

Natural and Semi Natural spaces

- 5.24. In terms of Natural and Semi Natural Spaces, limited provision has been identified throughout the County. There are settlements, however, with provision and this includes Monmouth/Wyesham which exceptionally has a large total amount of 78.09ha, attributed to the semi natural space at Vauxhall fields. Chepstow has also been identified has having a good-sized provision of natural and semi natural due to a large area at Warren Slade (there is only a small deficit of-.0.23ha within Chepstow). In contrast, smaller amounts of provision have been identified within the settlements of Abergavenny/Llanfoist and Caldicot.
- 5.25. In relation to Severnside settlements, some provision has been identified within the area, with Rogiet enjoying good sized provision due to the asset of Rogiet Countryside Park (see Table 9). Various areas within Magor Undy (see Table 8) have a been identified and also semi natural spaces at Sudbrook recreation ground and Harold Park, Portskewett. In terms of the standard, however, there is deficit in all of the Severnside settlements.
- 5.26. With regards to our Secondary Settlements, all three settlements have limited provision, with an area of semi natural space identified adjacent to the tennis/basketball courts at Chepstow Road, Raglan (see Table 14), and a small area including pond in the Castle Oak area of Usk (see Table 12). No provision has been identified within Penperlleni.
- 5.27. The majority of our rural settlements have no provision of natural and semi natural space. There is surplus provision, however, identified in Llandogo at the Cleddon Shots area of open space (see Table 18), and also Trellech with various areas of natural/semi natural open spaces identified (see Table 27).

6. Table 2: Overview of Open Space Provision

- 6.1. Table 2 below sets out an over view of the amounts of open space provision for each open space typology in Monmouthshire's settlements. The **red figures** indicate a deficit against the FIT standard, and the **green figures** indicate a surplus against to the FIT standard. See individual settlement tables and maps set out in **Section 8** for surplus/deficit amounts and further analysis of open space provision.
- 6.2. The geographical locations of the County's open space provision are also set out on the RLDPs Proposal's map.

7. Allotment and Community Growing Provision

- 7.1. As well as surveying our open space provision, an audit has also been undertaken of the County's allotment provision, which includes some managed by MCC, some by Town and Community Councils and some by private allotment associations, as set out in Table 3 below.
- 7.2. The Primary settlements of Abergavenny (inc. Llanfoist), Chepstow, Monmouth (inc. Wyesham) and Caldicot all have some provision of allotments. However, when assessed against the FIT standard of 0.3ha per 1000 population, there is a deficit of provision in each of these Primary settlements.
- 7.3. In Severnside, Magor with Undy, Sudbrook and Rogiet have allotment provision. However, both Magor with Undy and Sudbrook have a deficit in relation to the FIT standard. In contrast, Rogiet has a surplus.
- 7.4. In our Secondary Settlements, while both Raglan and Usk have allotment provision, there is no provision within Penperlleni. There is a surplus provision in Usk and Raglan meets the standard provision requirement exactly.
- 7.5. In terms of our Rural Settlements, there is only provision in Devauden, Llangybi and Werngifford Pandy. Both Llangybi and Werngifford have a surplus of provision, however there is deficit in Devauden.
- 7.6. The geographical locations of the County's allotment provision are set out on the RLDPs Proposal's map.

Formal Open Space

Abergavenny has a deficit in all categories of formal open space with a large deficit of-18.21ha for outdoors sport, and-11.49ha for playing pitch provision. There is also a deficit of-2.65ha for designated play areas and-3. 62ha for other outdoor provision.

Although there is a deficit in outdoor sports it is recognised that Abergavenny does have a variety of outdoor sports provision, with facilities such as a cricket ground, tennis courts and bowling green (OPS0014) and tennis courts and bowling green also provided at Bailey Park (OP0023). There is also athletics running track available for public use at King VIII Henry School, as well as multiple MUGAS and several sports playing pitches at the school, as well as other locations within Abergavenny. There are several (14) designated children's play areas throughout Abergavenny and a skate park (OPS0020) at Abergavenny Youth Centre.

Informal Open Space

In terms of informal open space there is a healthy surplus of amenity greenspace, however there is a deficit of parks and gardens and natural and semi natural open space. Two large parks and gardens have been identified within the Abergavenny settlement: Bailey Park (OPS0024) and Linda Vista Gardens (OPS0061). It should also be noted that aspects that are classified as amenity green space, could in fact be also classified as natural and semi natural spaces or parks and gardens, for example OP20032 Castle Meadows has been classified as amenity greenspace, however it is recognised there are elements of natural and semi-natural within this space.



Chepstow has a deficit in all categories of formal open space with a large deficit of-16.51ha for outdoors sport and-6.65ha for playing pitch provision. There is also a deficit of-2.40ha for designated play areas and-1. 11ha for other outdoor provision.

Although there is a deficiency in outdoor sports it is recognised that Chepstow does have a variety of outdoor provision, with tennis courts, bowling green and cricket pitch (OPS0501 and OPS0099) at Chepstow Athletic Club. Chepstow Comprehensive School and Leisure Centre also provides numerous facilities including sport playing pitches, MUGAs and tennis courts. There are several (12) designated children's play areas throughout Chepstow and there is a skate park (OPS0093) within the Bulwark area.

Informal Open Space

In terms of informal open space there is a healthy surplus of amenity greenspace, however there is a deficit of parks and gardens. Natural and semi natural open space only has a minor deficit of-0.23ha. It should also be noted that aspects that are classified as amenity green space, could in fact be also classified as natural and semi natural spaces or parks and gardens, for example OPS0088 Castle Dell has been classified as amenity greenspace, however this could also be classified as park and gardens. Of note, two public square gardens have recently been created as part of the Fairfield Mabey new residential development (OPS0488 and OPS00490).





Caldicot has a deficit of-13.57ha for outdoors sport and a deficit of-2.03 for designated play areas. It does however have surplus provision for playing pitches and other outdoor provision. Although there is a deficit in outdoor sports it is recognised that Caldicot does have a variety of outdoor provision, with tennis courts, cricket nets basketball courts and a running track (OPS232) at Caldicot Comprehensive School and Leisure Centre as well as sport pitches (OPS0231) and a large area of MUGAs (OPS0233). King George's Field and Caldicot Rugby Club also provide sports pitches for the community. There are several (8) designated children's play areas throughout Caldicot and a skate park (OPS0233) at the Leisure Centre.

Informal Open Space

In terms of informal open space there is a healthy surplus of amenity greenspace + 33.53ha, however, there is a deficit of natural and semi-natural green space and parks and gardens. It should also be noted that aspects on informal open space that are classified as amenity green space, could in fact be also classified as natural and semi natural spaces or parks and gardens. For example, Caldicot Castle (OPS0230) has been classified as amenity greenspace space, however this could also be classified as parks and gardens. Of note, a large new area of amenity greenspace (OPS0495) has also been recently created at Church Road, as part of the new residential development.



Magor with Undy has a deficit in all categories of formal open space with a deficit of-9.19ha for outdoors sport, and-3.13ha for playing pitch provision. There is also a deficit of-0.96ha for designated play areas and-1.55ha for other outdoor provision. Although there is a deficit in outdoor sports provision, it is recognised that Magor with Undy, is part of the Severnside Cluster of settlements and there is provision of outdoor sports in the nearby Primary Settlement of Caldicot. Provision in Magor with Undy does include a football sport pitch provision at Undy Football Club (OPS0286) and there is MUGA provision at Magor Community Centre (OPS0283).

Informal Open Space

In terms of informal open space there is a surplus of amenity greenspace +4.04ha, however there is a deficit of natural and semi-natural green space and parks and gardens. It should also be noted that aspects that are classified as amenity green space, could in fact be also classified as natural and semi natural spaces or parks and gardens. A large new area of amenity greenspace (OPS0280) has also been recently created at Rockfield Road, as part of the new residential development.



Rogiet has a deficit in all categories of formal open space with a deficit of-2.86ha for outdoors sport, and-1.53ha for playing pitch provision. There is also a deficit of-0.11ha for designated play areas and – 0.485ha for other outdoor provision. Although there is a deficit in outdoor sports provision, it is recognised that Rogiet, is part of the Severnside Cluster of sustainable settlements and there is provision of outdoor sports in the nearby Primary Settlement of Caldicot. Rogiet does have a sport pitch provision (OPS0316) and there is MUGA (OPS0319).

Informal Open Space

In terms of informal open space there is a surplus of amenity greenspace +5.43ha and natural and semi-natural green space +9.87ha. It should also be noted that aspects that are classified as amenity green space, could also be classified as natural and semi natural spaces or parks and gardens. Rogiet Countryside Park (OPSO312) part of the wider Gwent Levels wetlands provides a publicly accessible area of informal open space that can also be used for amenity purposes.



Portskewett and Sudbrook have a deficit in all categories of formal open space with a deficit of-2.77ha for outdoors sport, and-0.43ha for playing pitch provision. There is also a deficit of-0.08ha for designated play areas and – 0.52ha for other outdoor provision. Although there is a deficit in outdoor sports, it is recognised that the settlements of Portskewett and Sudbrook, are part of the Severnside Cluster of sustainable settlements and there is provision of outdoor sports in the nearby Primary Settlement of Caldicot. Portskewett and Sudbrook do have a sport pitch provision (OPS0308 and OPS0304) and there are four designated play areas within the settlements.

Informal Open Space

In terms of informal open space, there is a surplus of amenity greenspace +6.12ha and natural and semi-natural green space +2.60ha, however, there is a deficit of-1.38 in relation to parks and gardens. It should also be noted that aspects that are classified as amenity green space, could be also classified as natural and semi natural spaces or parks and gardens. Of note, a large new area of amenity greenspace (OPS0507) has also been recently created on land west of Sudbrook, as part of the new residential development.



Caerwent has a deficit in all categories of formal open space with a deficit of-2.71ha for outdoors sport, and-1.62ha for playing pitch provision. There is also a deficit of-0.14ha for designated play areas and-0.51ha for other outdoor provision. Although there is a deficit in outdoor sports it is recognised that the settlement of Caerwent, are part of the Severnside Cluster of sustainable settlements and there is provision of outdoor sports in the nearby Primary Settlement of Caldicot. Caerwent does have a sport pitch provision (OPS0261) and there are four designated play areas within Caerwent. No public formal open space has been identified within the settlement of Crick, however similarly provision could be accessed in the Primary Settlement of Caldicot.

Informal Open Space

In terms of informal open space there is a surplus of amenity greenspace +1.39ha in Caerwent, but a deficit of natural and semi-natural green space of-3.39ha and a deficit of-1.36 for parks and gardens. It should also be noted that aspects that are classified as amenity green space, could be also classified as natural and semi natural spaces or parks and gardens, such as Highfield Recreation Ground (OPS0262). As with formal open space, no informal open space has been identified within Crick. Crick is therefore deficient in open space provision.

Formal Open Space

Usk has a deficit of-4.01ha for outdoors sport, a deficit of-0.31 for designated play areas and a deficit of-0.68 for other outdoor provision. It does however have surplus provision for playing pitches. Although there is a deficit in outdoor sports provision, it is recognised that Usk does have a variety of outdoor provision, with tennis courts and cricket nets (OPS0347) and a MUGA (OPS0348) at Usk Athletic Club. Penpergwm/The Bryn has a deficit of outdoor sport, other outdoor provision and playing pitch provision. There is however a surplus of designated area of play (OPS0477).

Informal Open Space

In terms of informal open space there is a surplus of +0.16ha with two identified areas of amenity greenspace within the settlement (OPS474 and OPS0476). There is no provision of parks and gardens and natural and semi natural open spaces and therefore a deficit of these open spaces.


