The orders detailed above are scheduled to come into effect in a staggered manner on the dates specified in brackets.

If any person wishes to question the validity of the Order or any of its provisions on the ground that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within six weeks from **13th January 2026** (being the date the order was made) apply for that purpose to the High Court.
