a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The premises supervisor, Adrian Morales Maillo shall ensure that all times when the premises are used for the sale of alcohol to the general public, there are sufficient competent staff on duty at the premises for the purpose of fulfilling the terms and conditions of the licence and for preventing crime and disorder. All staff will undertake training in their responsibilities in relation to the sale of alcohol, particularly with regard to drunkenness and underage persons. Records will be kept of training and refresher training as a part of the HACCP programme.

b) The prevention of crime and disorder

Any incidents of a criminal nature that may occur on the premises will be reported to the Police. All staff will be trained and supervised to ensure the effective and responsible management of the premises. It won't be tolerated any disrespectful behavior inside or outside the premises.

c) Public safety

Appropriate risk assessments and fire safety procedures will be carried out for the property. All electrical equipment will be inspected and certified annually. All emergency exits will be kept clear at all times.

d) The prevention of public nuisance

Customers will be asked to leave quietly. The operational hours will be closely controlled. Zero tolerance policy with any disrespectful behavior will be put in place.

e) The protection of children from harm

The licensee and staff will ask persons who appear to be under the age of 25 for relevant photographic ID. All staff will be trained for underage sales prevention regularly. A register of refused sales shall be kept and maintained on the premises. Unaccompanied children will not be admitted to the premises.

 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
