A playing field in Gilwern village that will be operating as a small festival site for the day in question. There is a football pitch in the centre of the field, a small play area and a skate-ramp area. There is also an all weather tennis/netball enclosed court.

The Llanelly Hill community centre is located next to the field as is the local bowls club.

There will be an entertainment stage located at the south west end of the field as well as a bar tent and food providers. There will be local stall holders located along the side of the football pitch area, running down towards the skate ramps. Children's activities will be running within the football pitch area and in the field area at the east side.

There are 2 main entrances to the playing field, one from the car park, next to which the welcome tent will be situated, and one next to Brynglas housing area.

M Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

We have an event management team with designated persons responsible for safety, security and site management. All team members and associated volunteers will be fully briefed in risk assessments and event management plans to ensure that the licensing objectives are met and the event runs smoothly.

We will be hiring SIA registered security staff to help ensure safe running under all aspects of the objectives.

Training will be given to bar volunteers which they will need to sign to say they have received and understood.

There are risk assessments in place as well as a fire evacuation policy, which all volunteers will be made familiar with.

b) The prevention of crime and disorder

We will be hiring licenced security personnel to monitor the event and have a presence around the perimeter. We will also have volunteers with radios to communicate any issues so that they can be dealt with quickly.

An incident book will be kept in the bar area so that any persons refused alcohol due to being intoxicated or underage can be recorded.

c) Public safety

The event health and safety policy and risk assessments are all documented and all contractors and volunteers working at the event must work within these procedures.

All food vendors have appropriate food safety certification.

We will have a first aid crew on site to respond to any incidents and a clearly marked tent area that will be used for first aid and as a meeting point.

We have a PA system that will be used in the case of any evacuation or major emergency and there are numerous exits from the playing field.

Fire extinguishers will be present and tested in stage, bar and food areas.

Litter sweeps/picks will be conducted before, during and after the event to ensure no dangerous items are left on the ground.

Drinks will be provided in plastic reusable glasses so no glass or broken plastic should be present on the site.

d) The prevention of public nuisance

Music will finish by 19.00 at the latest so there is no sound disturbance late into the night.

All bar staff will be trained to not serve alcohol to persons believed to be drunk and, if there are any issues, security staff will be on hand to escort any problem people out of the premises. There will be no low cost alcohol or irresponsible promotions of alcoholic drinks.

Noise levels will be monitored throughout the day.

e) The protection of children from harm

Bar staff will be trained to 'Check 25' and to check each time someone is served.

Acceptable ID is a passport, driving licence, National ID or Validate UK card.

Signs will be displayed stating that people must not purchase alcohol for under 18s and volunteers/security will visually check the grounds throughout the day for signs of any abuse of the rules.

All activities and music is 'family friendly' and will not contain unsuitable content or messages; all participants have been informed that the focus of the event is family fun.

There is a child protection policy and the Welcome tent will also serve as the meeting point for children separated from adults.

 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.

- a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.

- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.

- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a cop of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. The Home Office online right to

work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copy documents as set out above.
